
Total Inspection in Construction Sites

In 2015, three (3) operations were carried out.

Each operation focused in different scope/hazard,

- Operatian 1 Working at height
- 1. Operation 2 Concreting work
- 2. Operation 3 Lifting operation

We managed to achieve the target, and the total inspected construction sites were 1305 sites.




SMBF-2 Grading

- ii. Special checklist form

Information on DS-01-006 form was analysed using SMBF-2 and the results are shown.




Special Checklist Grading



Punitive Action


Punitive action is one of the improvements measures that issued to employers who violate the law enforced by DOSH.


Action can be issuance of NOI, NOP, Directive Letter, Prohibition Order (PL), Immediate Prohibition Order (PLS), Seizure, Compound and Prosecution.

The followings are the average of the entire construction sites visited and punitive actions taken by DOSH State






Notice of Improvement (NOI)

Classification of Notice of Improvement (NOI)


NOI is normally issued to the workplace/ plant/ substance/ process which may become dangerous.



Notice Of Prohibition (NOP)

Classification of Notice of Prohibitin (NOP)

NOP is issued to the workplace/ plant/ substance/ process that may pose an immediate danger.




Directive Letter

Classification of Directive Letter

Directive letter is a written statement regarding the violations need to be fixed by the employer.


Employers should take note of any instructions issued in this letter.



Prohibition Order

Classification of Prohibition Order (JKJ 110)

JKJ 110 is normally issued to machinery that do not have CF.




Immediate Prohibition Order

Classification of Immediate Prohibition Order (JKJ 26)

JKJ 26 is issued to machinery that is not safe.


Machinery is not allowed to operate until the officer is satisfied that improvements has been made by the employer.



Seizure

Classification of Seizure


Seizure is taken when officer finds that the workplace is not safe and pose a danger to workers and the public.



Compound/IP

Classification of Compound/ IP


Compound/ IP is a way for DOSH to submit a proposal of lawsuit to employers who violate the legal provisions.



Prosecution

Classification of Prosecution

For employers who violate the legal provisions, the prosecution is the final option for DOSH to take action against the employers.



Conslusion

- The three operations that were carried out in 2015, found that:
- 1. Operation is not only focused on the scope assigned, but other inspection was also conducted simultaneously;
- 2. There is an increased number of punitive action;
- 3. Specific attention is given to the scope of work at the construction site through special checklist provided by Construction Safety Division (CSD) of DOSH Headquarters.
