ROLE OF MBAM IN SAFETY AND HEALTH




- PROMOTE AND ENCOURAGE A SAFE AND HEALTHY WORKPLACE AT ALL CONSTRUCTION SITES



HUMAN RESOURCES - EMPLOYEE

- Employee plays very important role in S & H;
 - must know their role and responsibilities
 - Have basic knowledge on Safety and Health
 - Well trained and skilful in their own job duty.
 - Must be accountable for his action





HUMAN RESOURCES – EMPLOYEE TRAINING

- To equip the employee and enhance safety and health
MBAM took 2 approaches in training
 - Direct training in Safety and health
 - Indirect training i.e. to enhance the skill of employees

HUMAN RESOURCES – EMPLOYEE TRAINING



- **Competency Training**

- Site Safety Supervisor (SSS) Course
- Approved by DOSH
- Candidates are trained by the industry to meet industry requirement.
- Emphasis more on practical and being taught and tested by very experience industry players and DOSH
- The industry knows what he wants and what is expected from the candidate.
- As they trained by the industry the candidate are preferred by the industry
