## **PREFACE**

Under Regulation 5 (1), of Occupational Safety and Health (Use and Standard of Exposure of Chemicals Hazardous to Health) Regulations, 2000 (Hereinafter referred to as USECHH Regulations), an employer is required to identify and register all chemicals hazardous to health used at the workplace and record in a register known as REGISTER OF CHEMICAL HAZARDOUS TO HEALTH (Hereinafter referred to as the CHEMICAL REGISTER).

These Guidelines are intended to assist the employer in preparing the Chemical Register in pursuance of the above requirement of the law. The Chemical Register must contain all the information as required under the Regulations 5(2), USECHH Regulations, 2000, and other relevant information.

## GLOSSARY

### **By-Product**

Means a chemical substances produced with separate commercial intent during the manufacture or processing of another chemical substance (s) or mixture (s).

### **Chemical Abstracts Service (CAS) Number.**

A number assigned to a single chemical by the Chemical Abstracts Services (a US-based reference service) which serves to identify that chemical. Some mixtures (not many) are also assigned a CAS number. This is the only 'one chemical one number' system covering all publicly known chemicals.

### **Chemical Safety Data Sheet**

A document that describes the properties and uses of a chemical product or formulation including identity, chemical and physical properties, health hazard information, precaution for use; and safe handling information.

### **Intermediate-Product**

Means any chemical substances;-

- i. Which intentionally remove from the equipment in which it is manufactured
- ii. Which either is consumed in whole or part in chemical reaction (s) used for intentional manufacture of other chemical substance (s) or mixture(s), or is intentionally present for the purpose of altering the rate of such chemical reaction (s).

### **Waste**

Includes any matter prescribed to be waste and any matter, whether liquid, solid gaseous, or radioactive, which is discharged, emitted, or deposited in the environment in such volume, composition or manner as to cause an alteration of the environment.

## **PURPOSE**

The purpose of the Chemical Register to provide;

- Reference to employees regarding the presence of hazardous chemical at their workplace and information regarding health risk, and precautionary actions that need to be taken.
- Reference to employer to carry out training of employees in handling chemicals hazardous to health.
- Assist assessor in getting information for risk assessment.

## **APPLICATION**

Formulators, manufacturers, importers, distributors or users who are using chemicals hazardous to health at the workplace, are responsible to prepare the Register of Chemicals Hazardous to Health.

## **CONTENT**

The Chemical Register shall contain the following information;

- i. List of all chemicals hazardous to health that are to be used in the workplace.
- ii. Current Chemical Safety Data (CSDS) sheet of each of the chemicals hazardous to health.
- iii. The average monthly or yearly amount of each chemicals hazardous to health are produced or processed in the unit process.

- iv. The average monthly or yearly amount of chemicals hazardous to health are handled, stored, transport, disposal or treatment at the work area.
- v. The name, address and contact number of the local or foreign suppliers of each of the chemicals hazardous to health.

### **ACCESSIBILITY**

The Chemical Register shall be accessible to all employees at the place of work who may be exposed or are likely to be exposed to chemicals hazardous to health. The Chemical Register is useful for reference to Safety and Health Officer, Assessor, Fireman and Rescuer.

### **RECORD KEEPING**

The employer shall ensure that the Chemical Register be maintained in good order and condition, and up-dated from time to time.

### **EXEMPTION**

The requirement of preparing the Register shall not apply if the employers have complied with the requirement of Regulation 9 and 11 of the Environmental Quality Act (Scheduled waste), 1989 or Pesticides Act, 1974.

## RECOMMENDED FORMAT OF CHEMICAL REGISTER

The form is divided into three (3) section which is :

- SECTION A - COMPANY INFORMATION**  
*This section gives the information about the company using or producing chemical hazardous to health.*
- SECTION B - LIST OF CHEMICAL HAZARDOUS TO HEALTH FOR EVERY PROCESS OR LOCATION (2 DIFFERENT FORMAT)**  
*This section lists the chemical hazardous to health used or produced for each process or location.*
- SECTION C - NAME OF PERSON WHO PREPARED OR REVIEWED**  
*This section gives details on the preparing or reviewing the Chemical Register.*

The recommended format of the Chemical Register is given in Appendix 5.

## **Appendix 1**

Provides guide to complete the register. Employers may use this directly or may modify it, to include any additional information considered necessary for specific purposes or may enlarge the column width to fit their information.

## **Appendix 3**

Provides a list of class<sup>2</sup> of industry.

## **HOW TO COMPLETE THE FORM**

### **SECTION A: COMPANY INFORMATION:**

1. Enter the name and complete address of the workplace where the chemical hazardous to health as identified in Section B are being used.
2. Enter the Number of Factory Registration with the Department of Occupational Safety and Health (DOSH).
3. Enter the Code of Industry with reference to the Schedule 1 of the Occupational Safety and Health Act (OSHA), 1994.
4. Enter the Class of Industry with reference to the Industrial Classification of International Labor of Organisation (ILO).
5. Enter ( / ) the appropriate box (es) to indicate whether you are importer, manufacturer, distributor, formulator or end-user of the chemical hazardous to health.

## **SECTION B : LIST OF CHEMICALS HAZARDOUS TO HEALTH**

1. LOCATION:  
Indicate the name of location where the chemical (s) being used or produced.
2. PROCESS OPERATION:  
Indicate the name of process operation where the chemical (s) being used or produced.
3. NO. OF HAZARDOUS CHEMICAL  
Enter the total number of hazardous chemical being used for each of location or process operation.
4. NO. OF WORKERS:  
Enter the number of male and female worker of each of the process or location.
5. Enter the detail identification of each hazardous chemical being used :
  - a. PRODUCT NAME:  
  
Enter a registered trade name or product name of each hazardous chemical as stated in CSDS.
  - b. NAME OF CHEMICAL:  
  
Enter the chemical name according to internationally recognised nomenclature and other common synonym/ acronym as stated in CSDS.
  - c. PHYSICAL FORM OF CHEMICAL:  
Enter the type of chemical either

A	=	Aerosol	P	=	Paste
F	=	Fibre	PE	=	Pellet
G	=	Gas	PW	=	Powder
L	=	Liquid	SL	=	Slurry
N	=	Granule	S	=	Solid

d. **NO. OF WORKER EXPOSED:**

Enter the number of worker exposed to each of chemical used or produced.

e. **TYPE OF CONTROL MEASURES:**

Engineering Control

Indicate type of control measure (s);

E	=	Enclosure
I	=	Isolation
LEV	=	Local exhaust ventilation
GV	=	General ventilation
W	=	Water spray

**PPE**

Indicate the type of personal protective equipment (PPE) ;

C	=	Protective Clothing
E	=	Eye Protection
M	=	Dust Mask
R	=	Chemical Cartridge Respirator
O	=	others

f. **USAGE OF CHEMICAL:**

**TYPE:**

Enter the type of usage of each chemical used or produced at each process or location whether as:

B	=	By-product

S	=	Stored
W	=	Waste

Or, other uses as;

C	=	Cleaning
D	=	Degreasing
O	=	Other application

**QUANTITY:**

Estimate the yearly or monthly amount of chemical used or produced at each process or location. Quantity should be entered in 'kilogram ' or cubic meter' and should be expressed accurate to two (2) significant figures (for example, report 185 as 200 or 2,550 as 2,600)

g. **CAS NO.:**

Refer to Abstract service Number as stated in the SDS.

h. **NAME OF ACTIVE INGREDIENTS:**

If any, enter the name of active ingredients or dangerous components /constituents for each of hazardous chemical as stated in CSDS.

i. **COMPLY WITH CLASSIFICATION, PACKAGING AND LABELLING REGULATION, 1997:**

**CSDS**

Indicate (Yes / No) for chemical used provided with Chemical Safety Data Sheet (CSDS)

## **CLASS**

State the classification of the chemical under CPL Regulations, 1997.

### Note:

If the chemical is classified using other classification system, please enter NA.

## **LABEL**

Indicate (Yes / No) for chemical used provided with Labelling.

### j. **SUPPLIER**

Enter the name, address and contact number (tel. No./e-mail) of foreign or local supplier (s) whom DOSH may contact for clarification of information on the chemicals hazardous to health being supplied.

## **SECTION C. NAME OF PERSON WHO PREPARED OR REVIEWED**

### **PREPARED BY:**

#### **1. NAME, TITLE, SIGNATURE AND DATE:**

Enter the name, title and signature of the person who prepared the form and the date prepared.

### **REVIEWED BY:**

#### **1. NAME, TITLE, SIGNATURE AND DATE :**

Enter the name, title and signature of the person who reviewed the form and the date reviewed.
